# **Meeting Minutes**

The meeting started at 10:04 AM, with Duaa'.



#### 1. Chairman's Remark

Highlights:

The Chairman thanked everyone for joining the meeting. He also thanked the members who have been participating in work in various committee.

#### 2. July Monthly and Special Meetings Minutes Approvals

**Motion**: The motion to approve the July monthly and special meeting minutes was moved and seconded. **There was one abstention**. **Motion approved**.

#### 3. Formation of Election Committee

Highlights:

"The proposal is to continue this year with the same committee as last year. Background checks will be conducted. I will reach out to last year's lead and ask him to continue, and if he is not available, I will reach out to others."

"We should let candidates know ahead of time that background checks will be conducted. We will also need to keep candidates' sensitive information confidential. There are ample applications that can be used while protecting their information."

"As a board member, can I be part of the Election Committee?"

"I don't think there is any text prohibiting it, but we avoid it as a matter of principle."

"I have the same concerns regarding sharing sensitive information, such as social security number. I did not directly give my number when I ran, and the committee found a way to get the information through a portal."

"I suggest new people for the committee, so we have more people involved with our various committees, learning our processes. We can keep the same lead but add new members."

"I agree, we should explore bringing new members to the committee, including women."

"I suggest the Chairman send an email to the board members requesting names for the committee."



"There is a verse in the Quran where Allah (SWT) mentions people who are eligible for taking care of Masajid. We should ask a Mufti for guidance on this before we reach out to anyone online. [The verse in question is: Only those shall maintain Allah's mosques who believe in Allah and the Last Day and maintain the prayer and give the zakat and fear no one except Allah. (Surat al-Tawbah, No 9, Āyat 18)]"

"The stipulation from NAIT is that IFN will have to be part of their Waqf. Plus, the amount will probably not exceed \$300,000."

"I want to reiterate that we must increase the number of programs that will attract people to the Masjid. There is also no physical advertising of the construction project in our lobby."

"Is there a plan to bring in more professionals to help with this effort? Do we need to put a team together and start meeting regularly?"

"Yes. But the onus is on all of us to drive this, to support this, and to enlist the support of our community."



"I will look to you as the lead to put together functional teams, action items, and goals. We are ready to help."

"I think we should only focus on the \$100,000 for the Fall Fundraising, before we get into the other amounts for permitting fee and ground-breaking."

"Priority-wise, that's how we will proceed."

"We will get the permission from the GBM anyway. But we can raise the funds regardless, so the work is done in parallel."

#### 5. Policies Update

Highlights:

"We want to add the Confidentiality Agreement to our list of policies. I want to work with another member to complete the document, so that our board members can sign it in September. We will reach out to the Election Committee to make sure that the way confidential information is collected is secured."

#### 6. Capital Project Financials Future Direction

Highlights:

"No new update. We have covered this in the past couple of meetings. Are there any questions?"

"Are you meeting regularly?"

"We have not met since June, because we were waiting for the two special meetings on the Capital Project to complete. The goal is to identify what other sources of funding we could use, such as NAIT. Devon Bank."

"I see some redundancy of the work in this process. I suggest we combine our meetings between Fundraising, Financials, and Community Engagement teams."

"We can have a combined meeting, but there are specific items we should cover in our own separate meetings."

# 7. Capital Project Community Engagement Update

Highlights:

"Our focus is how to get the community engaged. We want to present the Capital Project to the EC. Next, we would like to go to as many committees as possible and talk to them about the project. We send out our Newsletter every month. We reached out to our Imam. We are also planning to create a video and ask various community members to speak for a few minutes why the project is important to them."



"I noticed we have an abundance of TV monitors at IFN. Can we display a video on some of these monitors? There is absolutely nothing that suggest a Capital Project is going on at IFN. We should also display a model of the project in our Masjid."

"I agree. In fact, I have the following items to ask the EC:

- 1. Announcements in the monitors.
- 2. A permanent sign in front of the prayer area on the 1<sup>st</sup> floor.
- 3. A box for donations to the Capital Project.

I also think displaying a model in the lobby is a great idea."

"One, the EC must make sure the Imam is making the announcement. Two, the EC should have handouts of pre-defined announcements. Three, I did not see much traffic coming the way of the information booth for the Capital Project at Eid."

"For point one, yes; the EC must ensure the announcements are made. For point two, yes; we have a four-bullet page we will share with the EC. For point three, yes, there were not many people who stopped by the booth at Eid."

### 8. EC Implementation of Youth Strategy Recommendations

Highlights:

"We have had a meeting with the committee. We are going to meet one more time and create sub teams for execution. Tomorrow we have the EC, and we will discuss what month to start the execution phase."

#### 9. IFN Clinic Update

"The team is looking to hold on-premise screenings starting with Sunday School, the first Sunday after Labor Day."


